4. Cattle with 2 or more teeth under 150.0kg will be priced at time of slaughter.
5. Livestock are to be loaded & delivered in accordance with the MLA "Fit to Load" Guidelines
6. Disposal charges may apply on animals arriving dead in transit, or downers destroyed out of hours.
7. Grid is a guide only final assesment of cattle will be done at slaughter point by NRM
8. All consignments are to be booked & confirmed prior to processing in order to secure price
